Many manufacturer websites stick you under their website, so if you want to leave, you have to start over with a new address and you lose your identity.

Seasonal changes are included– If you want to change your coupon, text, or offers to match the season, just fill out and fax us the change form. You can do major changes up to 4 times a year, 1 for each season. Minor changes can be done at anytime.

Website Terms and Conditions for the HVAC Template-based websites, by FivePaws DotNet Solutions, LLC

By signing the Authorization to start on the ***HVAC Website Signup Fax Form***, I (Client) agree to the following Terms and Conditions with FivePaws DotNet Solutions, LLC (FivePaws).

Website Content

During the design process, FivePaws may provide information or content, or reformat content provided by Client in order to meet Client design specifications. The Client will have an opportunity to review and sign-off on the design and content of the completed website. I understand that the Client is solely responsible for the content on this website, and that FivePaws is not liable for any information that has been published, whether the information has been provided by The Client, a third-party, or by FivePaws.

Domain Name

I authorize FivePaws to obtain a domain name for me. I agree to use this domain name with the template-based website I am authorizing FivePaws to design and host my website for a term of 12 months, and to keep my account in good standing. After 12 months, I may have full control of my domain name for no additional fee, and may choose to keep hosting with FivePaws, or I am free to choose an alternative. Prior to completing the 12 month hosting contract, I agree that FivePaws owns the domain name I have authorized them to create for me. If I decide to terminate my hosting contractor early, I may purchase the domain name for \$99, at which time I will be given full control of my domain name to do as I wish.

Ownership of Content

Because this is a template-based website, it is designed to run on a software platform designed by FivePaws, to be run on FivePaws servers. It cannot be transferred to any third-party. The content and the code to serve and run the websites in this program are the sole property of FivePaws.

Compliance with Laws and Vendor/Third-Party Relationships

The client is solely responsible for determining that their website content is in compliance with any supplier, vendor, or third-party relationships, or with U.S, Michigan, or local laws, and that if any disagreements or problems arise due to the content with any outside party or government agency, The Client will not hold FivePaws liable. Any violation of the law by the Client will terminate your hosting account and you may be subject to civil or criminal penalties.

Early Termination

Should the Client terminate their hosting contract or fails to provide payment on-time, or fails to maintain their account in good standing, or violates any part of these terms as determined by FivePaws, Client understands their website may be removed from our hosting server(s) and no longer be available on the Internet. Early termination does not give the Client any rights to the domain name except as outlined in the section "Domain Name".
